Year-End Net Assets, a 6.8% increase from 2023, with gains reinvested to expand mission services and strengthen infrastructure.

\$7,900,000

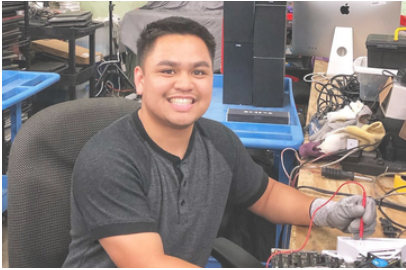
Supported an average of 850 employees, including 100 team members actively enrolled in career development training at any given time.

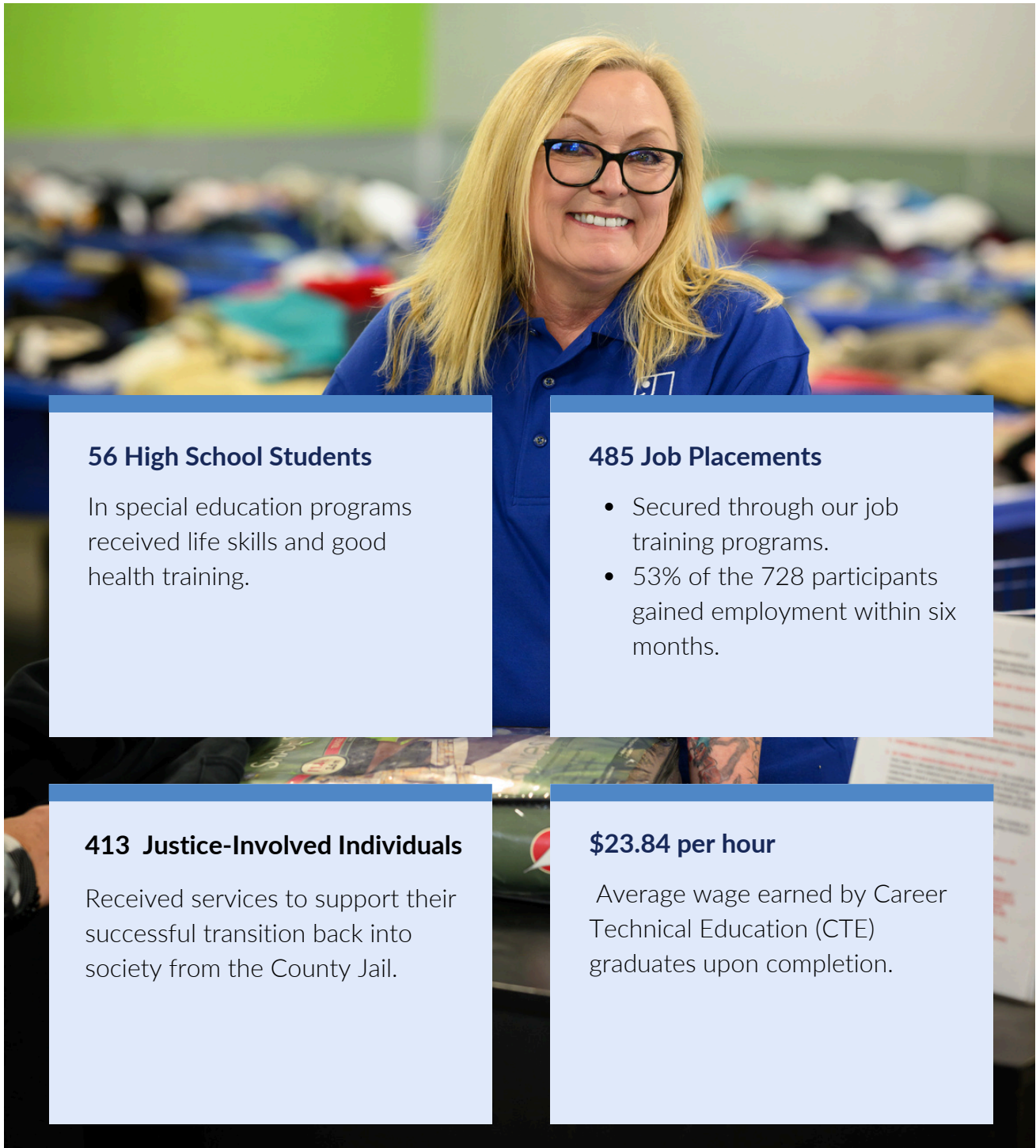

Breaking Barriers, Building Futures: Goodwill's Programs at a Glance

07

Goodwill of Silicon Valley operates 11 community-based programs, each designed to address a specific need while advancing our shared mission: empowering individuals to achieve economic independence. Our services primarily support veterans, individuals experiencing homelessness, people with disabilities, and those impacted by the justice system, but are available to anyone in our community facing barriers to employment. All programs are offered at no cost, and each year, thousands of individuals benefit from our job training, employment support, and career development resources.



Apprenticeship Program

Registered apprenticeships in retail and other sectors for Goodwill of Silicon Valley employees, blending paid employment with structured training to prepare participants for high-demand careers.



Career Development Program (CDP):

A six-month paid work experience for all entry-level employees at Goodwill of Silicon Valley, focused on retail, e-commerce and warehouse roles. The program combines on-the-job training with personalized coaching to build career pathways and boost confidence.



Career Technical Education (CTE)

Hands-on training for careers in high-demand industries, including IT, healthcare and construction. Certifications offered include California Class A Commercial Driver's License, electrical fundamentals, and HVAC. Programs feature flexible scheduling, job placement support, and are available at no cost to anyone in the community.



Expandability

Customized job services for individuals with disabilities, including employment readiness, workplace integration support, and one-on-one job coaching to promote independence and long-term success.



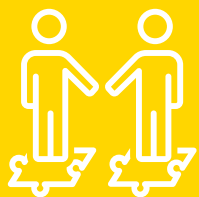
GoodHealth

Delivers health education, social-emotional learning, and life skills training to students with moderate to severe special education needs, supporting their independence through classroom instruction and community-based experiences.



In-Custody GoodStart Store

A first-of-its-kind initiative providing women in custody with hands-on job training in a fully operational retail store, where they gain experience in inventory management, merchandising, and customer service. Upon release, all women in custody receive two complete outfits at no cost—supporting their reentry with dignity, confidence, and a stronger path to employment and independence.



Neurodiversity Pathways

Increases employment opportunities for neurodivergent individuals, including those with autism, ADHD, dyslexia, and other cognitive differences, through career readiness training and coaching. The program empowers individuals to succeed professionally while helping organizations build workplaces where diverse minds can thrive.



New Opportunity Work (NOW) Program

Transitional employment and job readiness training for individuals reentering the workforce after incarceration, with a focus on reintegration, stability, and skill-building.



STRIVE

Combines emergency interim housing with employment training and placement services for individuals experiencing homelessness, helping them achieve stability and reenter the workforce.



Veterans Employment Program (VEP):

Personalized career coaching, training, and job placement for military veterans. Offers industry-specific programs (e.g., HVAC, IT, Medical Assistant) as well as holistic resources like housing assistance, transportation, and access to professional attire.



Veterans Family Services (VFS):

Temporary financial aid, housing navigation, legal support, and benefit access for unhoused or at-risk veterans and their families, with a goal of long-term housing and employment stability.

Innovation: First-Ever Store Inside a Correctional Facility

09



In October, Goodwill of Silicon Valley launched a pioneering initiative at the Elmwood Correctional Facility—the first retail store in the nation within a correctional setting. Participants receive hands-on workforce training by organizing and running the store themselves, gaining essential skills in warehousing, inventory management, logistics, and sales. Born from our decade-long partnership with the Santa Clara County Sheriff's Office and the Reentry Resource Center, this first-of-its-kind initiative exemplifies our commitment to redefining second chances by leveraging community collaboration to rehabilitate offenders, reduce recidivism, and provide incarcerated individuals with tools for new beginnings.

Provided at no cost to every incarcerated woman upon release, to leave the jail system with dignity.

Strategic Expansion: New Headquarters Acquisition

10

Goodwill of Silicon Valley acquired a modern office building at 1600 Technology Drive to house our headquarters and select mission-services programs. This achievement was made possible through fiscal prudence, close attention to operational details and a unique set of circumstances:

- Philanthropic Support: A \$10 Million Gift from philanthropist MacKenzie Scott in 2020, the largest single donation in our history.
- Market Opportunity: A post-COVID decline in office values allowed us to secure the property for \$17 million, repurposing an empty building to benefit the community.
- Community Support: Continued community generosity and trust has laid this expansion's foundation.

This move also supports future renovations of our 75-year-old warehouse on North Seventh Street. Above all, this expansion enables us to better serve our community with expanded mission-services programming and infrastructure.
